Wind Turbine Resolutions were presented to the board recommending that the county board put a temporary moratorium on the building of Wind Turbines in Schoolcraft County until more research could be done.

The other resolution was in support of the zoning ordinance #508, Section 102 CCC with added conditions for bonding for road and decommissioning of the wind turbines. Motion was made to present these 2 resolutions to the Schoolcraft County board by C. Watchorn Supported by K. Stapleton 3 in favor and 1 against with 1 abstaining to vote due to signed lease with Heritage. Vote was called

C. Watchorn, K. Stapleton, and K. Silkworth voted yes and B. Landis was no. B Spaulding abstained.

Kelly got in touch with Big Bay de Noc School to see what the added benefit would be to the school if the turbines came in and she was told that it is done like the lottery system. So if Heritage gave the school \$500 for a student then the state would only give them \$500 more for that student. You only get \$1,000 per year per student. They did state that the sinking fund has gotten about \$34,000 from them.

A little league presentation was given by Jason Dougherty. He stated that we had to purchase a new home plate and that the score board was not functioning properly. He also stated that the ball field needs fill. Motion to get a load of fill was made by C. Watchorn Supported by K. Stapleton AIF M/C
