FD/EMS from Brad Benard ... There was no activity between last month and this month's meeting, but with snow melting and dry grass exposed, the busy season is approaching. Officer elections were held at the last department meeting, resulting in new leadership: Ryan Swagart and Ryan Knoph as Lieutenants, Walt Thompson and Scott Williams as Captains, Jon Guertin as Assistant Chief, and myself continuing as Chief, likely for my final year. Jon will shadow me to prepare for the Chief role, with plans for me to become his Assistant Chief afterward.

Regarding the hall situation, members voted to contribute \$50,000 plus annual corn roast proceeds toward a new hall if the board chooses that route, with a minimum yearly amount to be determined. If the board opts to repair the existing building, corn roast funds will continue to be used for upgrading outdated fire equipment and gear. Additionally, we are funding the wiring and lighting of the new 382 truck, followed by similar work on the rescue trailer.
