If a middle ground is reached and pavilion repair costs are reasonable, the group is willing to cover them.

If the current hall is remodeled, temporary truck storage will be necessary. The trailer and two rescue trucks can be stored under the pavilion, and John Swanson has offered space at his US-2 storage facility for the three larger trucks.
