**FD/EMS** *Summary from Brad Benard ... We had no calls this month. The radio for 382 finally arrived and will be installed by Sinetech. We're also getting flag holders and flags to honor past members, and board members are asked to share any names to include.*

*Since the mill fire meeting, I've been working to find a company to service the pumper. One finally came last Thursday, and what was supposed to be a quick job turned into a full weekend. The pump hadn't been serviced in nearly 20 years, and several major issues were found and repaired, including a bad primer motor, incorrect packing, non-working drains and inlet, and several DOT safety issues like ungreased springs, bad filters, a failing pulley, and seized brake adjusters.*

*The pumper passed its NFPA pump test on Sunday for the first time since 2014. I'm requesting approval to have this company do annual inspections and service on the three trucks to prevent future major repairs. Both tankers need DOT and service. The mechanic also recommended a coolant flush, new thermostat and cap, and adding a third battery. I'll be flushing the tank myself to clear sand buildup. Although costly, this work was long overdue, and regular maintenance will help ensure safety, reliability, and compliance moving forward.*
